


VILLAGE OF GERMANTOWN 2024 PROPERTY TAX

As you view your property tax bill remember that your property tax bill is divided among four taxing jurisdictions: Washington County, Village of Germantown, the Germantown School District, and the Milwaukee Area Technical College. The pie chart shows the percentage division of the tax collected for each of the taxing jurisdictions.

The property tax bill for each individual property is calculated by multiplying the property tax rate by the assessed value for the property, and then adjusting for State tax credits. TO PAY BY MAIL: THROUGH January 31st Only

Use the enclosed envelope. [This is a lockbox which delivers directly to US Bank.]

Or you can mail your payment in a separate envelope to:

Checks should be made payable to **Village of Germantown**. [Remember to endorse any escrow check(s).]

The lock box will be closed February 5th. Payments received after this date will be forwarded to Washington County.

Please be aware that the bank lock box does not save envelopes, as such, postmarks cannot be verified.

End-of-Year Payments (credited as a December 31, 2024, payment): Lockbox payments dated December 2024, and received via mail by January 5th, will count as an end-of-year payment, and will be credited for December 31st.

TO PAY BY MAIL: AFTER January 31st

Mailed payments after January 31st, should be made payable to **Washington County Treasurer**; and should be mailed to: Washington County Treasurer, PO Box 1986, West Bend, WI 53095-7986.

TO PAY AT US BANK: The **US Bank** branch office, located at **N96 W18480 County Line Rd**, will accept payments during regular business hours **through January 31st only**. This is a payment location only. Questions regarding your bill should be directed to Village Hall.

TO PAY IN PERSON: **Germantown Village Hall**, located at **N112 W17001 Mequon Road**, will accept payments during regular business hours of 8:00 AM to 4:30 PM, Monday through Friday, through **January 31st only**.

Please Note: Village Hall will be CLOSED - December 24th, 25th, 31st and January 1st.

Forms of Payment include properly-endorsed escrow checks, personal checks, money orders, and EXACT change only payments. Credit/debit card transactions will NOT be accepted at Village Hall.

DROP BOX: **Germantown Village Hall**, located at **N112 W17001 Mequon Road**, through **January 31st only**. The secure drop box is located to the right of the front door of Village Hall, under the Clock Tower.

TO PAY ONLINE: Skip the Line – Pay Online!

All property tax **online payments** should be made directly through the Washington County Website at:

PLEASE NOTE:

Payments will be credited on the date received by Village staff. Refund checks will be mailed separately and may take up to three weeks to process. The Village does not mail payment receipts.

APPLICATION FOR DOG/CAT LICENSE

PLEASE COMPLETE ONE APPLICATION PER ANIMAL.

Licensing of dogs and cats is regulated by Germantown Municipal Ordinance 12.15(3): Licensing of Dogs and Cats & 12.15(4): Rabies Vaccination. Dogs or cats over the age of 5 months old must be licensed with the Village and have a current rabies vaccination. Dog and cat licenses can be obtained at Village Hall during normal business hours.
